

### PRIVACY POLICY

We, Benison Tech USA Inc respect data privacy rights and are committed to protecting personal information. This privacy policy ("Privacy Policy") sets forth how we collect, use and protect the personal information collected. This Privacy Statement applies to all Benison-owned websites, domains, services, applications, and products.

# Please read this Privacy Policy carefully.

For residents of the EU, please note that this Privacy Policy has been updated in accordance with the requirements of the EU General Data Protection Regulation ("GDPR").

For Non-EU residents, by continuing to use the services or access the website, you agree to this Privacy Policy. If you do not agree to this Privacy Policy, you may not avail the services or access the Website.

# 1. WHAT DATA DO WE COLLECT?

To sign up and use our Offerings, or to get in touch with us through the 'contact us' page, you are required to provide us with your name, (optional) telephone number, e-mail address, company name, and message. For the sake of brevity, the aforementioned information shall be referred to as "Personal Information".

Through our websites, we also collect certain non-personal information on the way you use the Website, through tools such as Google Analytics (a brief description of the same is provided below). These tools collect certain information which helps us understand how many visitors have visited the Website and also, their behavior.

Google Analytics-This Website uses Google Analytics, a web analytics service provided by Google Inc. ("Google"). Google Analytics uses cookies, text files that are stored on your computer and enable analysis of your use of the Website. The information generated by the cookies about your use of this website are usually transferred to a server of Google in the US and stored there. In case of activation of IP anonymization on this website your IP address from Google will be truncated within Member States of the European Union or other parties to the Agreement on the European Economic Area. Only in exceptional cases is the full IP address is transmitted to a Google server in the US and shortened there. You can refuse the use of cookies by selecting the appropriate settings on your browser software; however, we point out that you can optionally use to their full extent in this case not all features of this website. You can also prevent the data generated by the cookie and related to your use of the website to Google and the processing of these data by Google.



**For EU Residents**- As per the provisions of the GDPR we shall be considered the Controllers of the aforementioned Personal Information.

<u>Accuracy of information</u>. Please make sure that any Personal Information you share with us is accurate and upto date. If you are sharing any Personal Information on behalf of a third person, you should ensure that you are authorized to do so.

# 2. WHAT DO WE DO WITH YOUR DATA?

Depending on your use of our website or services, we use the Personal Information for the following purposes:

- (i) Provide a login credentials, provide support, deploying and delivering products
- (ii) to correspond with you;
- (iii) to provide you the Offerings and to assist you in the event you need any additional support;
- (iv) to manage our relationship with you;
- (v) for internal record keeping; and
- (vi) to comply with our legal or statutory obligations.

**Legal Basis (for people from the EU):** We will not process your Personal Information without a lawful basis to do so. We will process your Personal Information only on the legal bases of consent [as provided in Art. 6 (1) (a) of the GDPR], contract [as provided in Art. 6 (1) (b) of the GDPR], or on the basis of our legitimate interests [as provided in Art. 6 (1) (f) of the GDPR], provided that such interests are not overridden by your privacy rights and interests.

# 3. WHO DO WE DISCLOSE YOUR DATA TO?

We do not sell, rent, share, distribute, lease or otherwise provide your Personal Information to third parties, without your prior consent. Keeping this in mind, we may disclose your Personal Information in the following cases:

• <u>Merger or Acquisition</u>: We may transfer your Personal Information if we are acquired by another entity, or if we merge with another company or transfer a part of our business, including the Website, to a third party. Any such third party or resultant entity that receives your Personal Information shall have the right to continue to use your Personal Information in line with the purposes set out herein. In the event of such a sale or transfer, we may notify you.





• <u>Legal and Regulatory Authorities</u>: We may disclose your Personal Information in order to comply with our legal obligations/ court orders/ requests by Govt. authorities.

### 4. TRANSFER OF YOUR PERSONAL INFORMATION ACROSS BORDERS (FOR EU RESIDENTS)

We have a presence through our regional sales or delivery centers in US and India. The Personal Information we collect (of EU residents) might be processed outside the EU (in India or the US) at a secure center. We collect and transfer Personal Information outside the EU in accordance with EU data protection laws. We will ensure that any such transfers of Personal Information (outside the EU) will be governed by standard contractual clauses approved by the European Commission for this purpose.

### 5. HOW LONG DO WE RETAIN YOUR DATA?

We will retain your Personal Information as long as it is required to be retained for the purposes set out in Section 3 of this Privacy Policy, and to comply with our legal obligations. Subject to this section, we will try to delete your Personal Information upon reasonable written request for the same. Please note, however, that there might be latency in deleting Personal Information from our servers. #### 6. OUR SECURITY MEASURES

Although we provide appropriate, cloud security, firewalls and protections, we cannot warrant the security of any Personal Information transmitted as these systems are not hack proof. You are required to be careful to avoid "phishing" scams, where someone may send you an e-mail that looks like it is from us asking for your personal information.

### 7. YOUR RIGHTS

You have the right to access your Personal Information in our possession, right to have us rectify or modify any such Personal Information, right to have us erase/delete your Personal Information, right to restrict us from processing such Personal Information, right to object to our use of your Personal Information.
